## Waitsburg water system high-pressure incident

WAITSBURG — On Tuesday, November 4, Waitsburg's public works staff and a contracted crew encountered issues while working on the city's waterline. The city was working on two leaks, one on the corner of Coppei and Preston Avenues.

The repairs were on the same circulating line, and City Administrator Randy Hinchliffe stated that once certain valves were shut off, it created pressure zones, resulting in additional head pressure. At least one valve on the circulating water line failed due to age.

The city first heard from the Waitsburg School District, where the extreme water pressure resulted in non-functioning restrooms and leaking hot water tanks. Students were released early on Tuesday, and classes and parent-teacher conferences were cancelled for Wednesday due to sanitation concerns.

Residential damage included leaks from stressed seals and valves on appliances, such as dishwashers and washing machines. Most of the residential flooding was caused by hot water pressure relief valves releasing water.

The city issued a community update at 1:45 p.m. on Tuesday on its website. It advised residents that the city's water was safe to drink, as the problem did not involve any kind of source water contamination.

On Wednesday, the city held an emergency public meeting with information about the waterline issues. Hinchliffe estimated that at least 20 homes had been affected during the incident. He encouraged property owners to submit repair invoices to the city, which would accept them as long as needed.

Hinchliffe said the city's insurance will cover most of the

Mayor Marty Dunn stated that the water pressure had returned to normal and apologized for the inconvenience. "This wasn't done because we didn't know what we were doing. It was just something that accidentally happened," he said.

# Whiskey C temporarily closed due to fire damage

WAITSBURG — On Sunday at 9 p.m., an equipment malfunction caused a kitchen fire at the Whiskey C Restaurant on Preston Avenue. The business is temporarily closed due to the resulting damage. The owners Corben Ketelsen and Tommy Long said they hope to reopen within 30 days.

Ketelsen said the chef, the restaurant's unsung hero over the last few years, was the only person injured. He suffered severe burns to his right arm and hand after a reaction from a possible propane leak flashed in his face and torso. He is recovering and expected to make a full recovery.

Ketelsen and Long will know more about the extent of the damage after an insurance fire inspection is completed this week. They estimated the loss to the business to be as high as \$100,000, including lost revenue during the shutdown.

A significant concern for the owners is supporting staff while the Whiskey C is temporarily closed. Part-time employees do not qualify for "standby" unemployment benefits, and it is unclear whether insurance will cover lost wages.

# Community continues fight to save Prescott School District from dissolution

PRESCOTT — The Prescott School District is at risk of dissolution after ending the 2022-23 school year in a deficit. Since then, the Office of the Superintendent of Public Instruction has placed Binding Conditions on the district, allowing OSPI and ESD 123 to help restore financial health within two years.

After additional liabilities were identified, the district was unable to meet year-end requirements for the 2024-25 year.

At a school board meeting in September 2025, Shawn Lewis from OSPI informed the district that its financial situation was worse than previously thought. To avoid the possibility of dissolution, the district would need to find nearly \$1 million in additional funding.

The board has identified three paths to raise the funds by selling surplus property (including the Teachers Cottage), passing a levy, and successfully lobbying the state legislature to provide funds to the district.

The Prescott and Walla Walla Valley communities have stepped up to help raise money with a variety of fundraisers. The most recent is a partnership with the College Place Panda Express for a fundraising event on Sunday, November 16, 2025.

The Panda Express restaurant in College Place will donate 20% of the proceeds from meals purchased by Prescott's supporters on November 16. Diners can order at PandaExpress. com or on the Panda Express app and enter "3850796" in the fundraiser code box.

## **WASHINGTON INFANT AFFECTED BY A BABY FORMULA RECALL**

OLYMPIA — Organic baby formula, ByHeart, has recalled all of its products nationwide on Tuesday, after federal and state health agencies began investigating an outbreak of botulism linked to powdered infant formula produced by ByHeart.

Fifteen infants in 12 states have been hospitalized, including one infant from Lewis County, Washington. All of the reported outbreak cases were associated with the consumption of ByHeart brand powdered infant formula. ByHeart has voluntarily recalled the formula.

If you have recently purchased any ByHeart Whole **Nutrition Infant Formula:** 

**Do not use.** Throw it away or return it to the store where you purchased it. Record the lot number before disposing of it.

Wash items and surfaces that may have touched the recalled formula using hot soapy water or a dishwasher.

Seek immediate medical care if your infant has consumed ByHeart Whole Nutrition Infant Formula

and has any of these symptoms:

- Poor feeding
- Loss of head control
- Difficulty swallowing
- Decreased facial expression

Symptoms of infant botulism can take as long as several weeks to develop, so parents should remain vigilant if they used the recalled formula.

WAITSBURG — The Wilbur-Creston-Keller (WCK) football team triumphed over the Waitsburg Cardinals on Friday, November 7, winning 64-26.

"The season did not end the way we wanted it to, but usually only one team gets to finish the season on a win, and that's the state championship team," said Coach Gabe Kiefel.

The Cardinals had a good week of practice and went into the game confident against last year's 1B State Champions.

"The first quarter was a killer for us," said Kiefel. "We did not start making progress until our last possession of the first quarter, but at that point, WCK had a substantial lead."

After the game, Kiefel said he received praise from the WCK coaches about two Waitsburg players: JJ Gleason and Jarod Hankins. One of the WCK coaches, Darin Reppe, is a graduate of Touchet High School. They were impressed with quarterback Gleason's running and passing game. On offense, the coaches noted that WCK had to run

the ball away from Hankins, who put the hurt on their line.

Gleason scored two touchdowns in the loss, and he had another 100+ yards rushing. Isa Reyes and Martin Vasques each caught a ball and scored a touchdown.

On defense, Vaquez had 24 tackles, Hankins had 15, Tucker Hamilton had 14, and Koyen Fortune had eleven. Fortune also had three quarterback sacks.

At the All-League meeting on November 3, the coaches from the SE1B Wheat Division voted multiple players to be on the All-League 1st team. On offense, Isa Reyes and Landen were selected as wide receivers, and JJ Gleason as quarterback. Gleason was chosen as a defensive back, Jarod Hankins and Koyen Fortune for defensive line, and Martin Vasquz as linebacker. Honorable mentions included Victor Whitmore for both offensive and defensive line, and Tucker Hamilton for linebacker on defense.

"This team has worked harder for us in practice than I have seen as a coach in Waitsburg. They put it all out there day after day. We will be losing eight seniors. A hole that will be hard to fill. However, we have a few years to come with good athletes coming down the pike," said Kiefel.


#### PIONEER PORTRAITS

## Fifteen Years Ago

November 11, 2010

Six vehicles were reportedly entered over the weekend in Waitsburg, according to the Walla Walla County Sheriff's Office. Purses, wallets, credit cards, cameras, and more were taken. Nearly all the vehicles were left unlocked overnight, though several were reportedly locked but showed no sign of forced entry. Two Waitsburg households on E. 7th St. reported stolen purses with one brazenly snatched from inside a garage. The perpetrators got away with more than \$600 in cash around midnight Saturday and attempted to use the victims' ATM cards within the hour. Rose Engelbrite called in her incident as a warning to other Waitsburg Residents, particularly those who live close to Coppei and the football field, to be extra careful and secure their valuables. "It's hard to do in a small town," she said. "But these are hard times."

Bruce and Saunders have sold nearly \$10,000 worth of horses and mules this summer and fall, a good many of which were for army purposes. Ten thousand dollars is a neat sum to distribute among our farmers in this vicinity for horses.


