# Business Boosters, Lyons Ferry, and RVs at Port meeting

DAYTON—The Port of Columbia Board of Commissioners held its regular meeting at 5 p.m. on April 9, 2025, at the port's conference room. Commissioners Seth Bryan, Johnny Watts, Mike Spring, and Executive Director Jennie Dickinson were present

Dickinson presented the director's report. She said there were two new leases, a residential property and the Red Band Cellars units at the Rock Hill Industrial Park. Red Band signed a one-year lease for the three units with a one to two-year option and ended the lease for its tasting room at Blue Mountain Station.

Commissioners discussed samples of other port executive director job descriptions. Port of Pasco was the example the commissioners liked best. Dickinson is not leaving the position; however, the job description has not been updated since she was hired.

Dickinson said someone abandoned an RV full of garbage on port property. Kyle's Towing quoted \$3,000 to remove it. Unlike abandoned cars, RVs cannot be sold by the tow company but must be taken apart and disposed of.

Economic Development Director Shane Laib posted a photo of the RV on Facebook, and it was recognized by and taken away.

After the unfortunate death of Lyons Ferry concessionaire Tim Dewald, Dickinson said the previous owners, Wally and Joanne Knouff, will take the business back to run as they relist it for sale. Susan Dewald did not wish to keep the business.

Dickinson said the port was fortunate to have the Knouffs back. They still have their business license, and the KOA is letting them take over the franchise. They are restocking the store and looking for a maintenance person and a cook.

At Blue Mountain Station, Mountain Man Sourdough will go to month-to-month rental as they prepare to move to a down-town Dayton location

town Dayton location.

Dickinson said the design process had begun for the Mainstem Malt facility at BMS.

Discussing the broadband project, Dickinson said the state awarded an Internet Service Provider (ISP) 40 project areas, including in the Columbia County Port District. She could not say who it was, as the state has not released the information. It is unclear whether the deal will go through; she will keep the commissioners updated.

Dickinson said Puget Sound Energy will add 96 windmill turbines to its Lower Snake River wind farm over the next few years. The new turbines are larger and should help the county's tax base.

Glass recycling will return to Blue Mountain Station on the second Saturday of every month between 11 a.m. and 2 p.m., said Laib in his report.

Laib said the 13-event Business Boosters series had its first workshop, Magnetic Marketing," the previous night. Future topics include Quickbooks 101 and social media content creation.

# County vehicle surplus, water billing discussed at city council

DAYTON—Mayor Roger Trump called the Dayton City Council meeting to order at 6 p.m. on April 8, 2025. Trump, council members James Su'euga, Kyle Anderson, Michael Smith, Laura Aukerman, Glenn Hagfeldt, and Shannon McMillen were present at city hall. City Council member Joann Patras did not attend.

In public comment, Michael Brady Patton told the council that he moved to Dayton three to four years ago after retiring from the pharmaceutical and medical device field. He spoke about his water bill, saying there was no water usage data from December through March, and his April bill was the same as last year's. Patton thought the water and sewer bills were too high for the average Dayton resident. He suggested that the council consider ways to reduce costs, including cutting Sheriff's Department services.

Greg Skiffington conveyed concerns about the lack of traffic enforcement, mostly on Main Street. He said he witnessed near-accidents caused by excessive passing and inattention from sightseers on Main Street. He said it made it necessary for cars to move past the stop line on cross streets to see if it was clear to cross or turn onto Main Street.

"There's going to be an accident, and it's going to be fatal," said Skiffington.

Sheriff Joe Helm reported that his department responded to 384 incidents in the city out of 553 in March. There were 116 traffic stops, 23 other traffic calls, and seven traffic accidents. The sheriff's office will participate at the Columbia County Prevention and Wellness Fair at Flower Mill Park on Saturday, April 26, from 11 a.m. to 1 p.m.

County Commissioner Marty Hall said the county would soon have surplus vehicles available, including a 2007 Ford Expedition and several 2010 – 2014 Ford Explorers.

The council confirmed Kris Takemura's appointment to the Historic Preservation Commission.

The Complete Streets Project will resume on 4th Street. Trump said the city would notify affected residents when dates are confirmed. He said the city was looking at installing some solar-powered flashing pedestrian warning signs.

The city completed its purchase of 51.66 acres as part of the wastewater treatment project.

The council discussed ways the water and sewer bill could be modified to be more informative for customers.

Hagfeldt spoke about the Dayton School District's Key Communicator and scholarship programs. He said students would receive scholarships in a separate ceremony from the graduation ceremony on June 5, 2025, at the Fairground Pavilion.

The council announced the Second Annual Fishing Derby at the city's fishing pond will be held on April 23, 2025. The Washington Department of Fish and Wildlife will bring around 100 fishing poles and bait for the kids.

The council meeting adjourned just after 7 p.m.; the next meeting will be Tuesday, May 13, 2025, at 6 p.m.

### **BOATING SAFETY PROGRAM** TO FOCUS ON LIFE JACKETS **FOR PADDLERS**

OLYMPIA — Paddle sports, including kayaking, canoeing, and stand-up paddleboarding, are among the most popular activities in Washington State. A Recreation and Conservation Office study showed 52% of survey respondents participate in paddle sports, up 28% from a 2017 study.

Rising safety incidents show the importance of education on paddle sport safety. Paddle sports account for 61% of reportable boating fatalities between 2023 and 2024. Out of 22 paddle sport fatalities, 18 occurred when the individual was not wearing a life jacket.

In response, the Recreational Boating Safety Program has a new campaign on life jacket use while paddling built around Washington's Paddle Safe

The new campaign kicks off with a survey open to Washington residents to better understand the safety habits of recreators on the water. The survey will take approximately five minutes to complete, and the data will help inform education and safety efforts by the program in years to come.

"What folks might not know when getting out on the water is they are required to carry a life jacket with them by law," said Derek VanDyke, Recreational Safety Education Coordinator. "But having it with you won't save a life in case of an emergency — you have to wear it."

A motorized boat operator must take a boating safety course and obtain a boater education card. Participants in paddle sports do not have similar requirements and may not be aware of laws and safety practices on the water.

A hands-on, youth training program on kayaking safety skills is entering its fourth year. The Recreational Boating Safety Program, funded by a Washington State "No Child Left Inside" grant, partners with local organizations to host Paddle Safe courses. The course focuses on underserved and rural areas statewide and has taught over 1,175 kids to paddle safely, be a community safety advocate, and provide participants with life jackets to take home.

Paddlers of all ages are encouraged to be role models in their community by always wearing life jackets. Creating a safety culture around paddling will keep the sport safe and enjoyable.

About the Recreational Boating Safety Program The Washington State Parks Recreational Boating Safety Program works statewide to keep boaters safe and informed of applicable regulations. In addition to Recreational Boating Safety, the Boating Program trains and certifies Marine Law Enforcement programs across the state and administers the Clean Vessel Act to fund pump-out stations that keep Washington waters clean.





# **DAYTON LIBRARY AFFECTED** BY FEDERAL FUNDING CUTS

#### **Executive Order and IMLS**

On March 14, 2025, President Donald Trump issued an executive order targeting the Institute for Museum and Library Services and six other government institutes. This executive order called on the IMLS to 1) eliminate all non-statutory components and functions, and 2) reduce the performance of those functions and associated personnel to the minimum required in order to function. On March 31st, all IMLS staff were placed on administrative leave; soon after, a skeleton crew was called back to the office. The entire board of directors has also been fired.

Federal funding for IMLS makes up approximately 0.003% of the annual federal budget.

Washington, along with two other states, have had their IMLS grants canceled as of April 3rd, 2025.

#### **IMLS in Washington State**

In 2024, Washington received approximately \$3.9 million from IMLS, helping support:

- Libraries for the blind and print disabled, including the Washington Talking Book and Braille Library (WTBBL)
- Institutional Library Services (ILS) providing resources and support to incarcerated and hospitalized patrons
- Broadband access to rural and under-served communities
- Access to eBooks and other online resources, including the Washington Anytime Library Workforce development resource to support
- job seekers and employers Training for staff who provide Early Learning
- and Youth programming Resources for Tribal Libraries including digi-
- tization assistance
- Professional development and continuing education for library staff

### IMLS and the Columbia County Rural Library

The President's executive order concerning the Institute for Museum & Library Services will not affect the bulk of our services, as we are funded primarily through the county levy.

In addition to the above losses affecting all of the state, CCRLD is also losing \$12,661 in grants for library technology upgrades and professional development.



#### **Twenty-Five Years Ago** April 13, 2000

Waitsburg farmer Greg Zuger was one of 25 lucky sweepstakes winners from across the nation who had the experience of a lifetime driving a real, 630-horsepower NASCAR Winston Cup Stock Car recently. Zuger entered a drawing while attending a seminar on Ruby Fieldmaster Premium Ag Diesel Fuel at a Northwest Grain Growers, Inc.-sponsored seminar. The prize included airfare to Las Vegas, Nev., home of glittering lights and the Las Vegas Motor Speedway, where the Richard Petty Driving Experience gives regular folks the chance to run 30 laps in an authentic stock car. The group stayed at the Luxor Hotel/Casino.

#### Fifty Years Ago April 17, 1975

Cattlemen across the nation have their eyes on the Lacrosse Bull Test Station at Lacrosse, Wash, where on Thursday, April 24, will be held the first auction of registered bulls that have been tested under an electronic feeding system. A total of 260 bulls in 11 breeds have been on test for 140 days at the station which is operated by the Washington beef Cattle Improvement Association in cooperation with Washington State University. Every 28 days, these bulls were weighed twice on separate days. Every ounce of feed they consumed was weighed because of the electronic mechanism. Each bull has around his neck a yellow plastic chain with a fist-sized box that directs signals to the proper feedbox. When the bull is within four inches of his own feedbox, the little gadget allows the bull to stick his head in and eat.


T. M. McKinney's law office is now located on the east side of Main Street in the office formerly used by Martin Weller when in the lumber business.

has been subdivided into seven 30' x 70' garden spaces with water troughs to be used as raised garden beds, said Laib.

With uncertainty over the Dayton Day, Inc. board, the Columbia County Commissioners provided funds to continue the annual rodeo under Loyal and Charlotte Baker's leadership.

To support the Memorial and Dayton Days weekend, Laib said the port is moving its flea market event to the fairgrounds on May 24 and 25. The port will run the non-food vendors at the fairground's youth and pavilion buildings. In addition, the Dayton Chamber will organize a parade.

Laib said the Li'l Shack is now the restaurant concessionaire at the Touchet Valley Golf Course. With Li'l Shack, there are now four Dayton restaurants serving breakfast, including The General Store, Locally Nourished, and Moose Creek.

Laib described implementing a vacant building campaign, and Commissioner Watts told him how impressed he was with his work since being hired.

Dickinson gave a presentation on housing. She said Columbia County home prices have decreased slightly since the peak. She showed data that Columbia County housing is not affordable but is improving, but not for first-time home buyers.

The meeting then went into a brief executive session to discuss a real estate matter and returned without taking any action.

The next meeting of the Port Commissioners is May 14, 2025.




