## Horseshoe Prairie Nordic Area Adventure

WESTERN, OR. — Blue Mountain Land Trust (BMLT) hosted a celebration party on February 8 at the Horseshoe Prairie Nordic Area Trailhead in Oregon. The event marked the opening of the Blues Crew Warming Hut and the addition of new trails, bringing the total mileage to 26 (24 ski/2 snowshoe dedicated) miles. The Blues Crew provided hot soup (the Coconut/Butternut Squash was excellent), hot chocolate, and cookies alongside a toasty fire and informative conversations about BMLT and its mission.

We set off from Waitsburg at 8:00 a.m., fueled by Ten Ton lattes and the promise of a Nordic adventure. The one-and-a-half-hour scenic route included a stop at Tollgate Crossing Store to pick up an Oregon Snow-Park Pass.

We brought our skis and snowshoes, but rentals are available in Walla Walla at Dusty's Ski, Snowboard & Skateboard Shop, and Whitman College Outdoor program. Adventure-Fit in Walla Walla offers guided trips and equipment rentals at the Nordic park.

The snowshoe trails required breaking trail through fresh 6" to 8" of snow, however the Nordic and cross-country ski trails were groomed for track and skating by volunteers from the BMLT

Blues Crew. Overall, the trail signage was good, though overcast and low snowpack impacted trail marker visibility, providing another level of adventure to the day.

The Horseshoe Prairie trail system traverses through rolling hills, forests, and open meadows for a variety of backcountry experiences for novice to expert winter recreational users.

BLMT website has comprehensive information on trail etiquette, maps, and snow and groomed trail conditions. One should be prepared for winter backcountry recreation with appropriate gear and up-to-date weather information. For this trip, I made sure to pack the following:

- Sunglasses
- Layered clothing
- Hat and gloves
- Water, snacks
- Nordic skis and snowshoes
- Oregon Snow-Park Pass
- Trail maps
- Sense of humor

And don't forget your sense of adventure.

Access to the Horseshoe Prairie Nordic area is at the Andies Prairie Snowpark parking lot at milepost (MP) 26 on Oregon Hwy. 204.

## "Barns of Columbia County" Exhibit at the Dayton Historic Depot

DAYTON — The Dayton Historical Depot Society is delighted to announce the opening of its much-anticipated public exhibit, "Barns of Columbia County," from February through December 2024 at the Dayton Historic Depot.

The exhibit is a journey through the agricultural heritage of Columbia County, showcasing the architectural styles, historical significance, and personal stories of the region's iconic barns. From architectural enthusiasts to history buffs, visitors will find an exploration of the role barns have played in shaping Columbia County's identity, with a chance to get up close with fascinating farming implements and displays.

Explore the multifaceted functions barns play for family farms, practical storage solutions, and recreational community space.

There are four barns highlighted that were transformed after receiving Washington Heritage Barn Restoration grants, preserving their legacy for future generations.

The exhibition will run through December 2024. Winter hours from February through April are 11 a.m. to 4 p.m., and summer hours from May to October are 10 a.m. to 5 p.m. The Dayton Historic Depot is at 222 E Commercial Ave, Dayton, Washington, and admission is free.

## Dayton School Board approve new coaches, hear from counselors

DAYTON — The Dayton School Board met at 6:30 p.m. on February 7, 2024. School Board Chair Jeffrey McCowen, members Zac Fabian, Aneesa Dieu, Grant Griffin, and Superintendent Rich Stewart were present. Ryan Paulson did not attend.

The board approved the consent agenda, including accepting the resignation of Jim Su'euga as MS Girls Basketball Head Coach and hiring Andee Thurston for that position. The board approved Tamira Culley as the MS Girls' Basketball Assistant coach, and Des Jones was approved as a volunteer coach for the MS Girls Basketball team.

Stewart introduced the K-12 counseling team, Kristie Korslund, Sasha Squires, and Caitlin Patterson, who presented to the board. Each counselor spoke about their background, history in the School District, and interaction methods with the students.

Korslund, whose focus in the district is substance abuse prevention, also works with the Columbia County Youth and Family Coalition and encouraged interested parents to learn more at <https://www.facebook.com/cc.cyf>.

After the presentation, the superintendent and board members continued discussing with the counselors for about forty-five minutes.

The K-12 Dean of Students, Hannelee Farrell, spoke on school discipline, emphasizing prevention of incidents and methodology for data collection and analysis. The board members and Farrell engaged in an active discussion after her report.

Stewart gave an update on the search for a permanent superintendent and expects a list of finalists to be completed for board review at the February 21, 2024 meeting. The board will go into an executive session to choose candidates from that list to interview.

The last action was to approve the purchase of a used truck and stock trailer for the FFA program using grant funds earmarked for that purpose.

The meeting adjourned at 8:21 p.m. The next board meeting is scheduled for Wednesday, February 21, 2024, at 6:30 p.m.

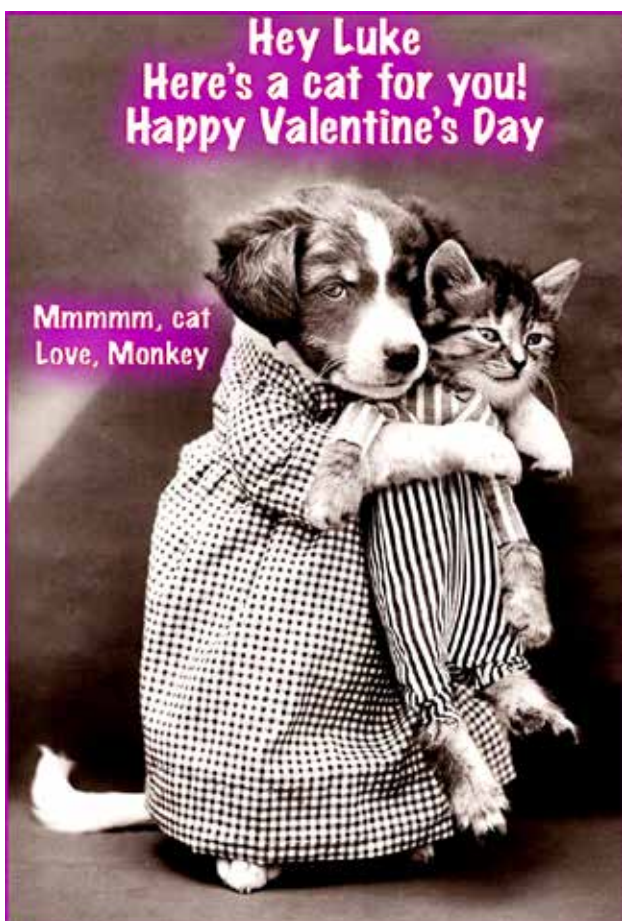

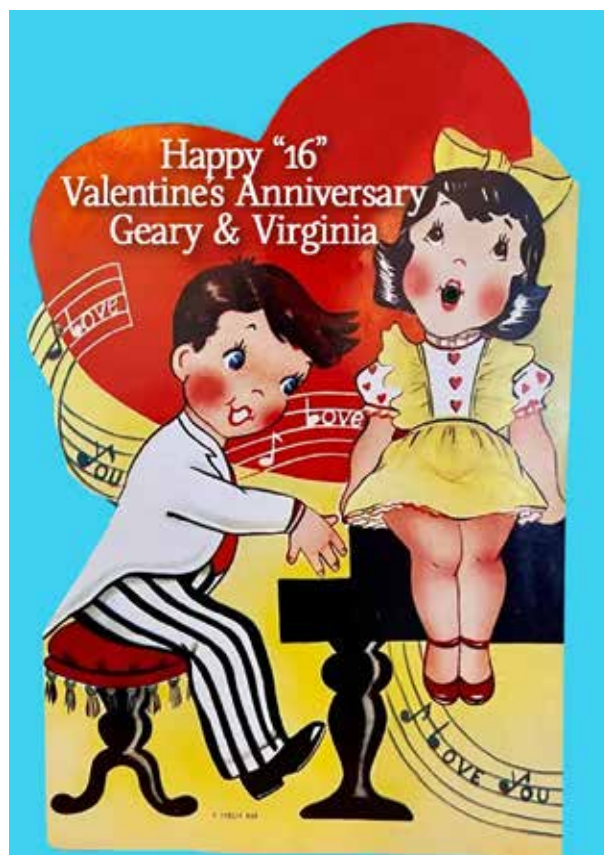

WAITSBURG — Izzy-the-camel owner Mickey Richards says he would love to one day write a book filled with stories about Izzy. If he does, that book will undoubtedly include a chapter on Izzy's most recent adventure as a television star.

Last week, Waitsburg's favorite cuddly camel was doused in fake blood (Karo syrup and food coloring) and transformed into a gruesome member of the Walking Dead to perform in an episode of the Syfy channel series "Z Nation."

The series, which is filming its second season, follows a group of survivors as they travel from New York to California, with a possible cure for the zombie apocalypse. Izzy will make his debut in episode five of the coming season, which premieres this fall.

Mickey said he had to admit that he didn't know what "Z Nation" was when he received a call from the show's production supervisor, Marc Dahlstrom, who was looking for a camel. "The kids knew, though. They went nuts — just freaked out," said Mickey's wife, Tawnya.

Dahlstrom had spotted Izzy two years earlier, before "Z Nation" was even in production. He'd been scouting for filming sites when he noticed Izzy in his pasturing off Highway 12. Dahlstrom took a photo of Izzy's trailer, with Mickey's phone number on it, in case he ever needed a camel. When "Z Nation's" producer said he wanted a camel, Dahlstrom knew just whom to call.

Less than two weeks after the initial phone call, Mickey, Tawnya, and children Kyle and Katelynn loaded Izzy and headed to the small town of Fairfield, Wash., just south of Spokane, where the episode was being filmed.

"It was a very opportune time because all the major characters were on set that day," Mickey said.

The Richards thoroughly enjoyed being part of a television episode in the making. They were invited to stay for lunch at the show's "base camp" where Tawnya said the caterers probably fed 200 crew and support people, for a show with only four or five main actors.

Mickey said he was amazed at the number of re-

takes required to get each scene just right. Of course, Izzy added to the count. In one scene, he was to walk a trail through the grass. He practiced it perfectly ten times, but as soon as the halter was off, the lure of a nearby wheat field proved to be too much temptation.

"I told the producer, 'As soon as I turn him loose, he's going for the wheat. That's heaven for him,'" Mickey said. They finally switched to a different trail and got the footage they needed.

Not surprisingly, charismatic Izzy quickly became a favorite with the show's cast. "The kids were asking to get pictures with the cast members, and the cast kept trying to take selfies with Izzy. Izzy almost out starred the stars," Tawnya said.

A favorite moment occurred when Mickey approached Izzy, who was being led by a "zombie" who had a shard of a flower pot extruding from his head. Mickey pulled Izzy's face to his own and said sternly, "Izzy, stay away from him. He's a pothead." The crew cracked up and the "zombie" was referred to as Pot-head for the remainder of the day.

The Richards family said they couldn't have asked for a better experience and that everyone bent over backward to make them feel comfortable. "They shot quite a bit of footage with a green screen, so we're excited to see what they're going to do with that," said Tawnya.

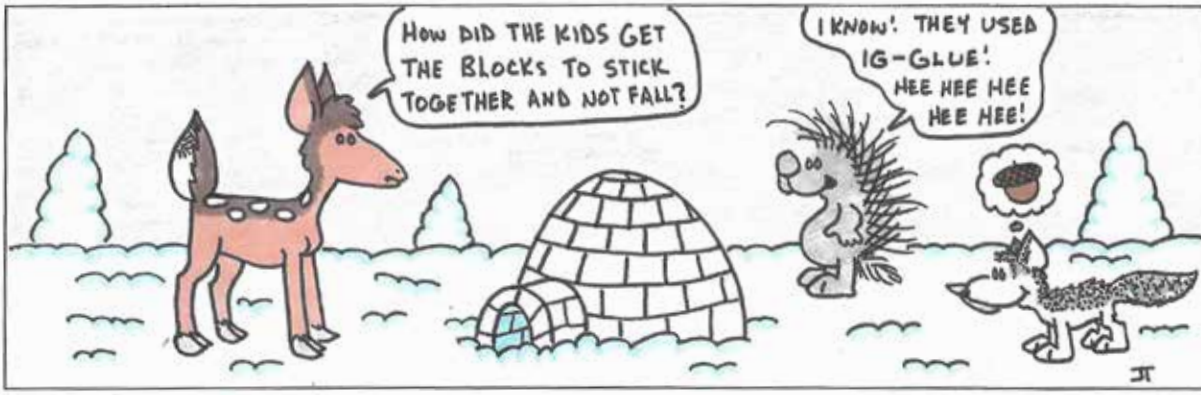
Mickey says he won't let Izzy get big-headed, but that he does plan to add a big, gold star reading "Starring in 'Z Nation'" to Izzy's trailer.

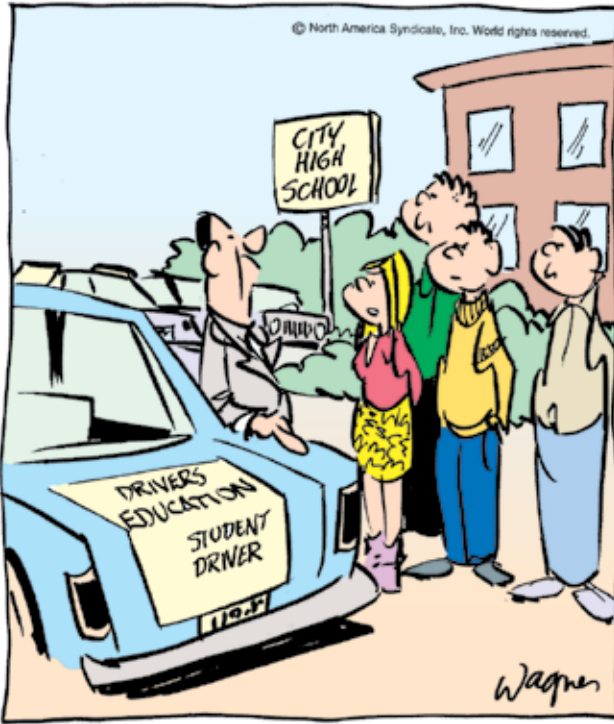

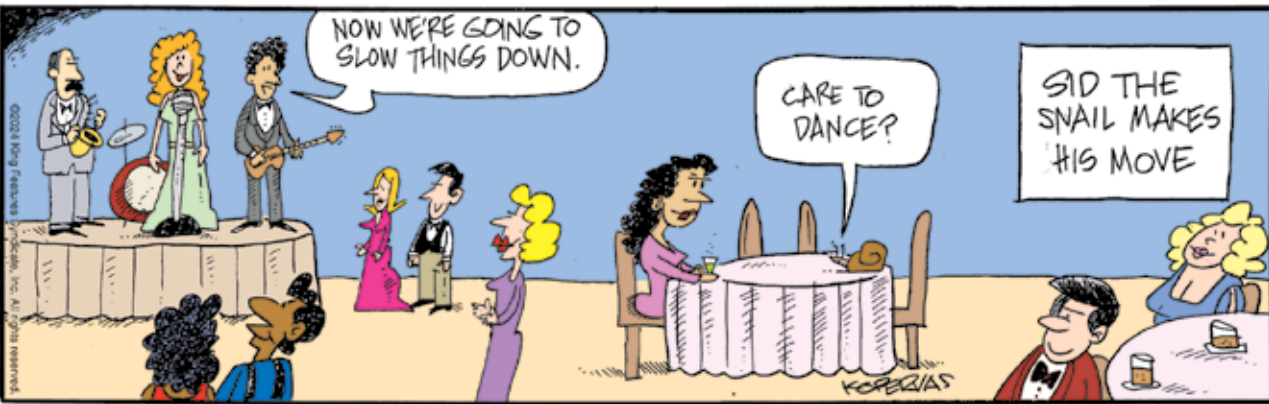

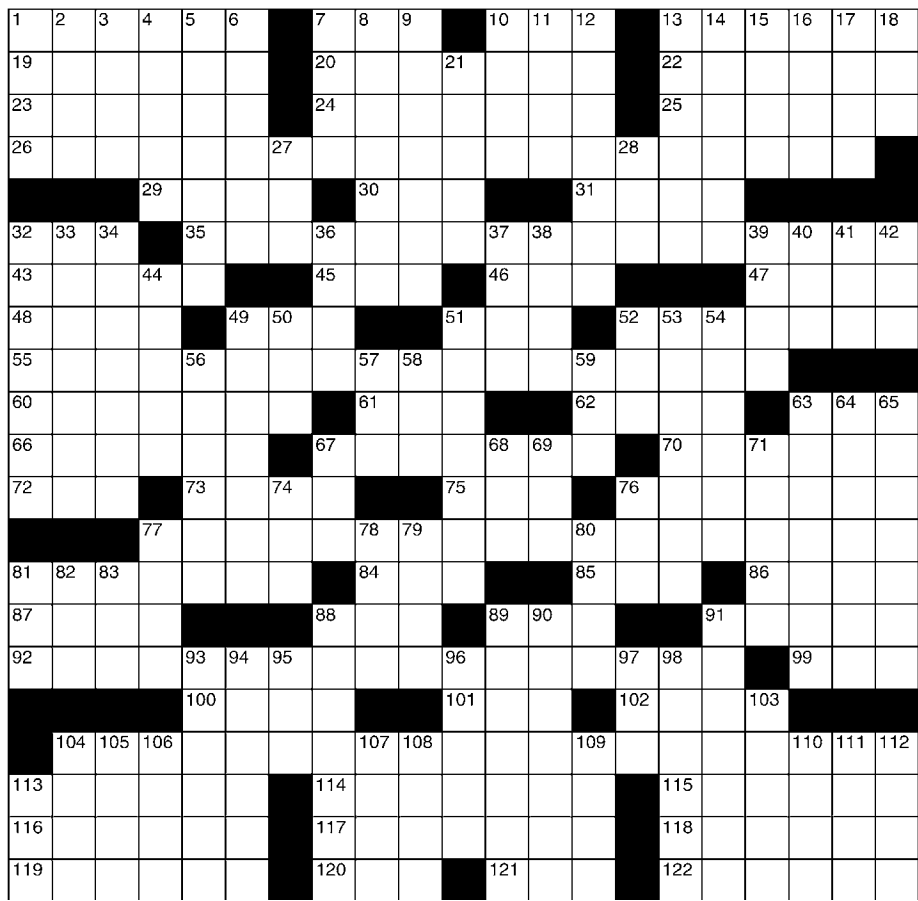

# Turkey Italian Wedding Soup



Little bits of green are popping up in our flower beds, and the backyard birds have been very active as of late. The change of season is rapidly approaching. With that, nights have still been a little chilly and I continue to find myself craving soup. This homey Italian American classic, with little meatballs and greens in a light broth, is satisfying without being too heavy. For my version, I used ground turkey and brightened things up with the addition of fresh lemon.

### Ingredients:

#### For the meatballs:

- 1 large egg
- 1 pound ground turkey
- ½ cup Italian seasoned breadcrumbs
- ⅓ cup finely grated Parmesan
- 3 tablespoons fresh parsley, chopped
- 2 garlic cloves, minced
- 1 teaspoon dried oregano
- 1 teaspoon kosher salt (or ½ teaspoon fine sea salt)
- ½ teaspoon fresh ground black pepper
- 3 tablespoons olive oil, plus more

#### For the soup:

- 1 large yellow onion, chopped
- 3 medium carrots, diced
- 3 celery ribs, diced
- 2 to 3 garlic cloves, minced
- Salt and fresh ground black pepper
- Pinch crushed red pepper flakes
- 8 cups chicken broth
- ¾ cup small soup pasta (orzo, ditalini, or acini di pepe)
- 3 cups packed baby spinach
- Zest of one lemon, plus the juice
- Grated Parmesan, for serving
- Chopped fresh parsley, for serving

### Directions:

First make the meatballs. Crack the egg into a large mixing bowl and lightly beat it with a fork. Add the turkey, breadcrumbs, Parmesan, parsley, garlic, oregano, salt and pepper. Mix just until all ingredients are totally incorporated. Coat your hands with a small amount of olive oil, then form small meatballs using a heaping teaspoon of the mixture per meatball. Transfer the meatballs to a sheet pan as you go. You should have between 50 and 70 small (1-inch) meatballs.

In a large soup pot or Dutch-oven, heat 3 tablespoons of olive oil over medium heat. When the oil is shimmering, fry the meatballs in two batches, turning occasionally, until they are browned on all sides, about 3 to 4 minutes. Transfer to a paper towel lined plate and set aside.

To the same pot, add the onion, carrots, and celery and cook, stirring frequently, until the vegetables are tender-crisp, about 10 minutes. Add a little more oil if the pan feels too dry. Next, add the garlic with 1 teaspoon of kosher salt (½ teaspoon of fine), a crack of black pepper, and the pinch of crushed pepper flakes. Cook until fragrant, about another minute.

Return the meatballs to the pot, add the chicken broth and bring to a simmer over medium-high heat. When bubbling, stir in the pasta, lower the heat to maintain a gentle simmer and continue to cook, stirring occasionally, until pasta is tender, about 10 minutes.

Turn off the heat and stir in the spinach until wilted. Add the lemon juice and zest then taste for seasoning, adding more salt or pepper as needed. Serve in warm bowls, garnishing the tops with grated Parmesan, parsley, and a crack of black pepper. A little drizzle of extra-virgin olive is also lovely on top.

### Notes:

For a more traditional meatball, substitute the ground turkey with a combination of ½ pound ground lean beef and ½ pound ground pork. Instead of regular breadcrumbs you could also try using panko breadcrumbs for a different texture.

Instead of baby spinach you could also try any of your favorite greens, such as lacinato kale, chard, arugula, or baby mustard greens. For heartier greens, like kale, you might need to keep the soup simmering while they wilt and get tender. If you can find it, escarole would be a fantastic, and very Italian option.

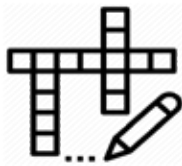
The soup will continue to thicken as it sits. When reheating leftovers, you might need to add more broth to thin it out. Leftovers also freeze beautifully.

I served this with a crusty loaf of Italian-style bread, a crisp side salad, and plenty of cheese and extra lemon wedges on the table for passing around.

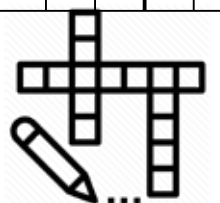
